



## STUDENT TRANSPORTATION CONSENT AND RELEASE

GO CAPS classes will be held away from your child's home high school. Neither GO CAPS nor the School Districts will provide transportation to or from GO CAPS classes.

Please review the transportation options listed below, check any that are acceptable for your student, sign the form, and have your student return the form to the teacher.

I/We hereby give my/our student, \_\_\_\_\_ (please print), a student enrolled in the GO CAPS program, permission to:

(Please check all appropriate spaces.)

- ride to and from GO CAPS activity events in District authorized vehicles
- ride with his/her parent,
- ride with an adult licensed driver,
- ride with a sibling who is at least 16 years of age and is a licensed driver,
- ride with another participant who is a licensed driver and at least 16 years of age,
- my student is at least 16 years of age, is a licensed driver, and can drive himself/herself,
- my student is at least 16 years of age, is a licensed driver, may drive himself/herself, and may transport other program participants.

I/We understand and agree that:

1. Employees of GO CAPS and the District do not have custody or control over student participants and are not responsible for the supervision of the student participants during the time they travel to or from the site of the GO CAPS programs, unless they travel in a District or GO CAPS authorized vehicle.
2. If the student is not traveling in a District or GO CAPS authorized vehicle, it is the responsibility of the student's parent/guardian to select and secure the mode of transportation for the student and insure that the student uses such mode of transportation to the exclusion of all other options. Neither the District nor GO CAPS will select or secure transportation for the student.
3. The driver who is selected by the student's parent/guardian and/or with whom the student rides to or from GO CAPS program locations, is not driving on behalf of, or as an employee or agent of GO CAPS or the District.
4. Neither GO CAPS nor the District have verified or have any duty to verify that the driver selected by the student's parents/guardians is properly licensed to operate a motor vehicle in the State of Missouri, has an acceptable driving record, has appropriate liability insurance on the vehicle, or that the condition of the vehicle is acceptable.

**Release** – I/We release and forever discharge GO CAPS and the District, their respective Boards, officers, employees, agents and representatives from any and all liability, actions, lawsuits, claims, demands and expenses resulting, directly or indirectly, from loss of life, personal injuries, property damage, or other damage suffered by my/our student while he/she is traveling to or from GO CAPS program class or activity events in a mode of transportation other than a GO CAPS or District authorized vehicle. I/We also understand that this Release binds our heirs, executors, administrators, legal representatives and assigns, as well as us.

I/We have read the entire Release. I/We fully understand the entire Release and acknowledge that we have had the opportunity to review this Release. I/We have been fully and completely advised of the potential dangers incidental to participating in this activity and are fully aware of the legal consequences of signing the Release.

This Release is effective until we revoke it in writing.
